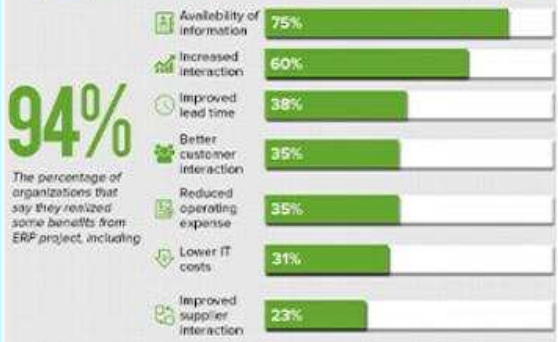

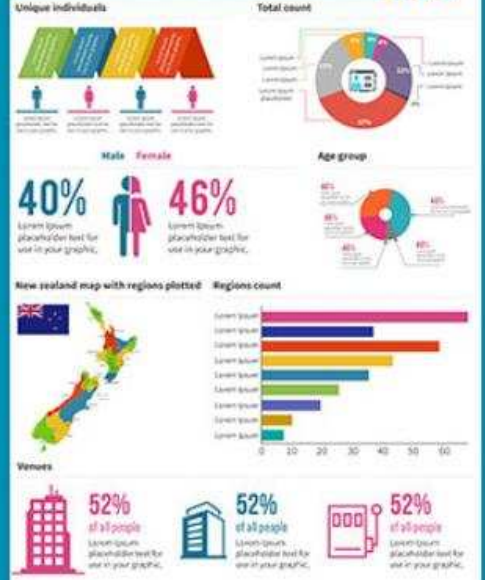

LEAD SAFE WINDOW REPLACEMENT



In April of 2010 the Federal Government passed a law that any home built in 1977 or prior requires lead-safe practices used during installation of their windows UNLESS they opt out.

- Rental properties
- Schools, churches, daycares, and businesses
